A M E N D M E N T INTERSTATE COMMERCE COMMISSION

AMENDMENT made and entered into this 14th day of DECEMBER, 1973, by and between United States Railway Leasing Company ("United") and Bumble Bee Seafoods, a Division of Castle & Cooke, Inc. ("Lessee")

R E C I T A L S

United and Lessee have heretofore entered into that certain lease ("Lease") dated October 3, 1972, recorded with the Interstate Commerce Commission as Recordation No. 6821, covering one insulated box car bearing car reporting marks USLX 11249. Lessee desires to extend the Lease for one year and United is agreeable to so do, all upon the terms and conditions hereinafter set forth.

A G R E E M E N T

It is agreed:

1. Paragraph 5 of the Lease is amended by deleting from the first sentence thereof the phrase:

"terminate one (1) year from the Average Date of Delivery"

and substituting therefor the phrase:

"terminate two (2) years from the Average Date of Delivery."

2. Paragraph 6 of the Lease is amended by deleting subparagraph (b) thereof in its entirety.

3. The Lease is further amended by deleting Rider No. 1 thereto in its entirety.

4. All other terms and conditions contained in the Lease shall remain in full force and effect, and the Lease

as hereby amended is hereby ratified, confirmed and approved.
