There is transmitted to you herewith for filing and recordation, pursuant to Section 20c of the Interstate Commerce Act, two duly executed counterparts of an Instrument of Release dated July 10, 1978 by Seaboard Coast Line Railroad Company, whose address is 3600 West Broad Street, Richmond, Virginia 23230.

By this Instrument of Release, Seaboard Coast Line Railroad Company released to Louisville and Nashville Railroad Company a 2250 H. P. Model U23B diesel-electric locomotive bearing L&N Railroad's road number 2718 from that Lease of Railroad Equipment dated as of January 1, 1973 between Seaboard Coast Line Railroad Company, as Lessor, and Louisville and Nashville Railroad Company, as Lessee, which was filed and recorded with the Interstate Commerce Commission on February 23, 1973 and assigned Recordation No. 6940.




