

SPECIFICATIONS --

1. Ballast material must contain a minimum of 50% of washed, crushed gravel as retained on a 1/2 inch screen but passing a 1-1/2 inch screen.

2. Ballast must be shipped in self-clearing HM-type railroad hopper cars loaded approximately 60 tons per car.
