AMENDMENT AGREEMENT dated as of November 15, 1973, between PULLMAN INCORPORATED (Pullman-Standard Division), a Delaware corporation (hereinafter called the MANUFACTURER), and TRAILER TRAIN COMPANY, a Delaware corporation (hereinafter called the Company).

WHEREAS the Manufacturers and the Company have entered into a Manufacturing Agreement dated as of July 1, 1973, and Amendment Agreements dated as of July 15, 1973, and August 15, 1973 (such Manufacturing Agreement as so amended, being hereinafter called the Manufacturing Agreement), filed and recorded with the Interstate Commerce Commission pursuant to Section 20c of the Interstate Commerce Act on July 12, 1973 (recordation number 7102-A), on July 27, 1973 (recordation number 7102-E) and August 31, 1973 (recordation number 7102-I), respectively; and

WHEREAS the parties hereto desire to amend the Manufacturing Agreement.

NOW, THEREFORE, in consideration of the mutual agreements herein contained, the parties hereto agree as follows:

1. Annex A to the Manufacturing Agreement is hereby amended so as to read in its entirety as set forth in Annex A hereto
2. Except as amended hereby, the Manufacturing Agreement shall remain in full force and effect.

3. The Company will promptly cause this Amendment Agreement to be filed and recorded with the Interstate Commerce Commission in accordance with Section 20c of the Interstate Commerce Act.
