


Dear Mrs. Lee:

NOTICE OF RENUMBERING PURSUANT  
TO LEASE DATED AS OF JANUARY 15, 1974

RECITALS:

INTERSTATE COMMERCE COMMISSION

Domestic One Leasing Corporation ("Lessor") and Grand Trunk Western Railroad Company ("Lessee") entered into a lease dated as of January 15, 1974, (the "Lease") of 29 flat cars (the "Cars") with rack assemblies, bearing road numbers GTW 303500 through 303528, both inclusive. The rack assemblies were subsequently sold and are no longer subject to the Lease.

The Lease was recorded with the Interstate Commerce Commission pursuant to Section 20c of the Interstate Commerce Act (now 49 USC §11303) and assigned recordation number 7500.

The Lease was deposited with the Registrar General of Canada pursuant to Section 86 of the Railway Act of Canada.

Section 4 of the Lease provides that the Cars may be re-numbered provided that the Lessor shall have been given notice of the renumbering and the notice shall have been deposited or recorded in such locations as the Lease had been deposited or recorded.


