



INTERSTATE COMMERCE COMMISSION  
DISCHARGE AND RELEASE OF LIEN

*partial release*

This Discharge and Release of Lien is executed as of January 1, 1986 by First Security Bank of Utah, N.A., acting not individually but solely as Agent under a Finance Agreement dated as of July 1, 1974 between itself, North American Corporation, and others (in such capacity, the "Lienholder") with respect to the covered hopper railcars described in Exhibit A hereto (the "Cars").

Pullman Incorporated (Pullman-Standard Division), as Vendor, and The First National Bank of Maryland, as Vendee, are parties to a certain Conditional Sale Agreement dated as of July 1, 1974, and recorded with the Interstate Commerce Commission (the "ICC") on August 21, 1974 at recordation number 7611. Lienholder hereby acknowledges that it no longer has any interest, claim or rights in or to the Cars, and hereby fully discharges and releases any lien on the Cars that it may have by virtue of the Conditional Sale Agreement, the Agreement and Assignment, as the same may have been amended at any time, or otherwise.
