WHEREAS, the parties hereto have entered into a Lease of Railroad Equipment dated as of July 15, 1974, (hereinafter called the "Lease") which was filed and recorded with the Interstate Commerce Commission pursuant to Section 20c of the Interstate Commerce Act on November 13, 1974, at 11:30 A.M., recordation No. 7708; and

WHEREAS, the parties hereto now desire to amend the Lease.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the parties hereto hereby agree as follows:

1. Schedule A to the Lease is hereby amended by substituting Lessee's Road Numbers NAHX 476000 through 476049 for Lessee's Road Numbers NAHX 476600 through 476649.

2. Except as amended hereby, the Lease remains unaltered and in full force and effect.


3. The Lessee will promptly cause this Amendment Agreement to be filed and recorded in accordance with the provisions of Section 16 of the Lease.


