

Also enclosed is our check in the amount of \$10., payable to the Interstate Commerce Commission, being the prescribed fee for filing and recording the foregoing document.





INTERSTATE COMMERCE COMMISSION

Amendment No. 1 dated as of December 6, 1978 between ITEL Corporation, Rail Division, successor in interest to SSI Rail Corp., ("SSI") and the Clarendon & Pittsford Railroad Company, ("Lessee"), amending that certain Lease Agreement made as of October 18, 1976 by SSI Rail Corp. and Clarendon & Pittsford Railroad Company as follows:

(1) Section 4B is hereby amended by deleting the following:

"until such time as the total number of Boxcars leased hereunder exceeds the total number of Boxcars owned or leased from others by Lessee. Thereafter, all recordkeeping shall be performed by SSI."

(2) Section 4C is hereby amended by deleting the following:

"until such time as SSI shall perform the recordkeeping functions, whereupon such correspondence shall be sent to such address as SSI shall select."

(3) Except to the extent hereby amended, the Lease Agreement is in all respects ratified, confirmed and approved as of December 6, 1978, but actually on this _____ day of _____, 1979.
