This Amendment to Hulk Purchase Agreement dated February 1, 1978 amends Exhibit A of that Hulk Purchase Agreement dated June 1, 1977 as amended to exclude and release from the terms and provisions of said Hulk Purchase Agreement the hulks described in the attached Schedule A and to substitute therefor the hulks described in the attached Schedule B.
