CERTIFICATE OF SATISFACTION AND DISCHARGE OF INTERSTATE COMMERCE COMMISSION OF AGREEMENT DATED AS OF APRIL 30, 1973, AND LEASE DATED MAY 7, 1973

KNOW ALL MEN BY THESE PRESENTS that PITTSBURGH NATIONAL BANK (Bank), one of the parties to that certain Agreement dated as of April 30, 1973, between THE PITTSBURGH AND LAKE ERIE RAILROAD COMPANY (Railroad) and Bank, lessor under a certain Lease of 500 used 70-ton hopper cars (Equipment) dated May 7, 1973, between Bank and Railroad, which Lease was recorded with the Interstate Commerce Commission on May 10, 1973, and assigned Recordation Number 7026, and deposited with the Registrar General of Canada on May 10, 1973, for and in consideration of the sum of One Dollar and other good and valuable consideration paid to Bank by Railroad, does hereby certify that said Agreement and Lease as above described are fully satisfied and discharged; provided, however, that with respect to the repurchase of the Equipment by the Railroad from Bank, the covenants and undertakings of the Railroad contained in Section 7.15^{10/15} of the Agreement will survive the execution and delivery of this Certificate and inure to the benefit of the Bank.
