Enclosed herewith for filing and recording with the Commission in accordance with 49 USC 11303 are two original counterparts of a Supplement, dated as of January 1, 1981, between The Atchison, Topeka and Santa Fe Railway Company ("Santa Fe") and Harris Trust and Savings Bank, as Trustee ("Trustee").

The Supplement was executed in connection with an Equipment Trust Agreement, dated as of January 1, 1976, between Santa Fe and the Trustee, whereby The Atchison, Topeka and Santa Fe Railway Company Equipment Trust, Series K, was created. 
