There is transmitted to you herewith for filing and recordation, pursuant to 49 U.S.C. Section 11303, two counterparts of an Instrument of Release dated as of April 1, 1980, executed by Seaboard Coast Line Railroad Company, whose address is 3600 West Broad Street, Richmond, Virginia 23230.

By this Instrument of Release, Seaboard Coast Line Railroad Company released two (2) 100-ton covered hopper cars bearing L&N road numbers 241266 and 241434 from that Lease of Railroad Equipment dated as of March 1, 1973 between Seaboard Coast Line Railroad Company, as Lessor, and Louisville and Nashville Railroad Company, as Lessee, which was filed and recorded with the Interstate Commerce Commission on March 19, 1973 and assigned Recordation Number 6961.

INTERSTATE COMMERCE COMMISSION

THIS INSTRUMENT OF RELEASE, dated as of this 1st day of April, 1980, by the undersigned, SEABOARD COAST LINE RAILROAD COMPANY (SCL), as Lessor under a lease dated as of March 1, 1973, by which it leased to the Louisville and Nashville Railroad Company (L&N) the railroad equipment listed therein;

W I T N E S S E T H:

WHEREAS, two units of said equipment bearing road numbers L&N 241266 and 241434 have suffered casualty occurrences and the Lessee has made a proper payment to the Lessor as required under said lease;

NOW, THEREFORE, for and in consideration of said payment, the receipt whereof is hereby acknowledged, SCL does hereby release its security title in the units bearing road numbers L&N 241266 and 241434 and release and discharge L&N, its successors and assigns, from the obligations under the lease in respect of said units.

This instrument of release shall be simultaneously executed in several counterparts, each of which so executed shall be deemed to be an original, and such counterparts together shall constitute but one and the same instrument.
