RIDER NUMBER 3, dated as of November 30, 1979, to the LEASE OF RAILROAD EQUIPMENT, dated as of November 2, 1979 (the "Lease"), between NORTH AMERICAN CAR CORPORATION, a Delaware corporation (the "Lessee"), and GENERAL ELECTRIC CREDIT AND LEASING CORPORATION, a Delaware corporation (the "Lessor").

Pursuant to Section 2 of the Lease, the units of railroad equipment described in Schedule A attached hereto (the "cars"), are hereby leased by the Lessor to the Lessee subject to the terms and conditions of the Lease.

The Lessee agrees to sublease the cars to Farmers Grain Company (the "Sublease") pursuant to a sublease dated as of January 24, 1979 (the "Sublease")

The annual rent for the cars for each year of the term shall be the amount indicated below:
