RIDER TO NACC LEASE

RIDER NUMBER 13, dated as of August 3, 1980, to the LEASE OF RAILROAD EQUIPMENT, dated as of November 2, 1979 (the "Lease"), between NORTH AMERICAN CAR CORPORATION, a Delaware corporation (the "Lessee"), and GENERAL ELECTRIC CREDIT AND LEASING CORPORATION, a Delaware corporation (the "Lessor").

Pursuant to Section 2 of the Lease, the units of railroad equipment described in Schedule A attached hereto (the "cars"), are hereby leased by the Lessor to the Lessee subject to the terms and conditions of the Lease.

The Lessee agrees to sublease the cars to Amenia Seed and Grain Company (the "Sublessee") pursuant to a sublease dated June 30, 1980 (the "Sublease").

The annual rent for the cars for each year of the term shall be the amount indicated below:

The cars shall be leased to the Lessee for a period commencing on the date of delivery thereof to Sublessee and continuing for a period ending five (5) years from the first day of the month following the average date of delivery of such cars, except as provided in Section 5 of the Lease.

The Lessee warrants and represents that the representations and warranties of the Lessee in the Lease are true and correct on and as of the date hereof as though made on and as of this date.
