AMENDMENT AGREEMENT
[L&N TRUST A] INTERSTATE COMMERCE COMMISSION

This Amendment Agreement dated as of December 2, 1980 among LOUISVILLE AND NASHVILLE RAILROAD COMPANY, a Kentucky corporation (hereinafter called "Lessee"), FIRST SECURITY STATE BANK, a Utah corporation, as Trustee (hereinafter called "Owner Trustee") under a Trust Agreement dated as of January 1, 1980 with LICC Corp., and FIRST SECURITY BANK OF UTAH, N.A., a national banking association, as Trustee (hereinafter called "Security Trustee") under a Trust Indenture and Security Agreement dated as of January 1, 1980 (hereinafter called the "Trust A Security Agreement") with Owner Trustee.

W I T N E S S E T H:

WHEREAS:

(a) The parties hereto, among others, have entered into a Participation Agreement dated as of January 1, 1980 (hereinafter called the "Trust A Participation Agreement") providing for the leveraged lease financing of the reconstruction of certain railroad equipment.

(b) Owner Trustee and Lessee have entered into a Lease of Railroad Equipment dated as of January 1, 1980 (hereinafter called the "Trust A Lease").

(c) The Trust A Security Agreement and the Trust A Lease were filed with the Interstate Commerce Commission pursuant to §11303 of Title 49, United States Code, on March 4, 1980 at 3:45 P.M. and were assigned recordation numbers 11554 and 11555, respectively.

(d) All equipment deliveries pursuant to the Trust A Participation Agreement have been completed, and the parties hereto desire to amend the Trust A Security Agreement and the Trust A Lease pursuant to Section 9(c) of the Trust A Participation Agreement to reflect the equipment subject thereto and to make certain other changes in such documents.

NOW, THEREFORE, in consideration of the mutual agreements herein contained and intending to be legally bound hereby, the parties hereto agree as follows:

1. Owner Trustee and Security Trustee agree that the Trust A Security Agreement is hereby amended as follows:

(a) Subsections (a) and (b) of Section 8.01 of the Trust A Security Agreement are each amended by deleting therefrom "10 Business Days" and substituting therefor:

five Business Days after there has been given to Owner, Owner Trustee and Lessee by Security Trustee or any Noteholder a written notice specifying such default and requiring it to be remedied

(b) Schedule I to the Trust A Security Agreement is hereby deleted and there is substituted therefor the Schedule I attached hereto. ✓

2. Owner Trustee and Lessee agree that the Trust A Lease is hereby amended by deleting Schedules A and B thereto and substituting therefor the Schedules A and B attached hereto.


3. Lessee will promptly cause this Amendment Agreement to be filed in accordance with the provisions of Section 15 of the Trust A Lease.

4. This Amendment Agreement may be executed in any number of counterparts, all of which together shall constitute a single instrument.

5. This Amendment Agreement shall be deemed to have been made under and shall be governed by the laws of the Commonwealth of Kentucky in all respects, including matters of construction, validity and performance.


