On January 21, 1982 the I.C.C. recorded as recordation number 12229-A, a Security Agreement executed by Schutzky Distributors, Inc., in favor of Wells Fargo Bank, N.A., as secured party. The I.C.C. also cross-indexed the Security Agreement to recordation number 12229, since the Security Agreement served as an assignment of payment rights under the Management Agreement bearing that recordation number.
