

AMENDMENT TO INTERIM USE AGREEMENT

MAY 30 1984 11 52 AM

INTERSTATE COMMERCE COMMISSION

AMENDMENT, dated as of May 31, 1984, by and between The Atlantic Land and Improvement Company ("AL&I") and Seaboard System Railroad, Inc. ("SBD"), both Virginia corporations.

WHEREAS, the parties hereto have entered into an Interim Use Agreement dated as of March 1, 1984, pursuant to which AL&I permitted SBD to use 28 Model SD-50 locomotives bearing road numbers SBD 8525-8552, inclusive, owned by AL&I, pending completion of financing arrangements by SBD; and

WHEREAS, said Interim Use Agreement expires on the earlier of May 31, 1984 or the date of payment of the purchase price of said locomotives; and

WHEREAS, SBD will not have its financing arrangements completed by May 31, 1984, and desires the continued use of said locomotives; and

WHEREAS, AL&I is willing to permit SBD to use said locomotives as bailee pending completion of financing arrangements;

NOW, THEREFORE, the parties hereto hereby agree that the Interim Use Agreement dated as of March 1, 1984, shall not expire on May 31, 1984, but shall continue until August 31, 1984, or the date of payment of the purchase price of the locomotives, whichever is earlier.
