**Gentlemen:**

This refers to the Equipment Trust Agreement dated as of December 1, 1978, between this Company and The Northern Trust Company, 50 South LaSalle Street, Chicago, Illinois 60675, as Trustee (the "Agreement"), which was recorded with your office on December 15, 1978, and assigned recordation number 9911.




