FIFTH SUPPLEMENTAL AGREEMENT,  
DATED AS OF APRIL 30, 1982,  
BETWEEN

MORGAN GUARANTY TRUST COMPANY OF NEW YORK, TRUSTEE  
AND UNION PACIFIC RAILROAD COMPANY

---

This FIFTH SUPPLEMENTAL AGREEMENT, dated as of April 30, 1982, between MORGAN GUARANTY TRUST COMPANY OF NEW YORK, a New York trust company incorporated and existing under the laws of the State of New York, as Trustee (hereinafter called the Trustee), and UNION PACIFIC RAILROAD COMPANY, a Utah corporation (hereinafter called the Company). (Terms used in this Supplemental Agreement shall have the same meanings as set forth in Section 1.1 of the Equipment Trust Agreement.)

WITNESSETH:

WHEREAS, the Trustee and the Company have heretofore entered into (i) an Equipment Trust Agreement, dated as of July 1, 1974, which was filed and recorded pursuant to 49 USC §11303 (formerly Section 20c of the Interstate Commerce Act) on June 28, 1974, and assigned Recordation No. 7554 and pursuant to which the Trustee has issued \$15,000,000 aggregate principal amount of Union Pacific Equipment Trust No. 6 of 1974 Equipment Trust Certificates (hereinafter called the Trust Certificates); (ii) a Letter Agreement, dated July 8, 1974, amending such Equipment Trust Agreement, which was filed and recorded pursuant to 49 USC §11303 on July 17, 1974 and assigned Recordation No. 7554-A; (iii) an Amendatory Agreement, dated as of April 1, 1975, amending such

such Equipment Trust Agreement, which was filed and recorded pursuant to 49 USC §11303 on April 17, 1975 and assigned Recordation No. 7554-B; a Second Amendatory Agreement, dated as of September 1, 1977, amending such Equipment Trust Agreement, which was filed and recorded pursuant to 49 USC §11303 on September 22, 1977 and assigned Recordation No. 7554-C; a Third Amendatory Agreement, dated as of January 1, 1980, amending such Equipment Trust Agreement, which was filed and recorded pursuant to 49 USC §11303 on February 8, 1980 and assigned Recordation no. 7554-D; and a Fourth Amendatory Agreement, dated as of November 1, 1981, amending such Equipment Trust Agreement, which was filed and recorded pursuant to 49 USC §11303 on December 22, 1981 and assigned Recordation No. 7554-E (such Equipment Trust Agreement, as amended being hereinafter called the Agreement); and

WHEREAS, certain of the Trust Equipment specifically described in the Agreement has suffered a casualty Occurrence under Section 4.7 of the Agreement, and the Company has deposited with the Trustee Replacement Funds equal to the Fair Value of such destroyed Trust Equipment; and

WHEREAS, the Company desires to transfer to the Trustee other equipment in substitution for the Trust Equipment which suffered a Casualty Occurrence and to receive as payment for such substituted equipment Replacement Funds up to the Fair Value of the substituted equipment, all in accordance with Sections 4.3 and 4.9 of the Agreement; and

WHEREAS, Section 8.4 of the Agreement provides that the Company and the Trustee without the consent of the holders of the Trust Certificates may from time to time and at any time enter into an agreement or agreements supplemental to the Agreement for the purpose of making any provisions in regard to matters or questions arising under the Agreement as shall not adversely affect the interests of the holders of the Trust Certificates then outstanding or the rights, duties or immunities of the Trustee; and

WHEREAS, the Company and the Trustee in accordance with Sections 4.3 and 4.9 of the Agreement, desire to execute and deliver this Fifth Supplemental Agreement for the foregoing purpose and such amendment will not adversely affect the interests of the holders of the Trust Certificates, or the rights, duties or immunities of the Trustee;

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the parties hereto agree that the Agreement be, and it hereby is, amended as follows:

(1) The Company shall sell, assign, transfer and set over unto the Trustee, subject to all of the terms of the Agreement, the following Equipment:

(2) Simultaneous with the transfer of the Equipment to the Trustee, the Trustee shall, pursuant to the provisions of Sections 3.4, 4.7 and 4.9 of the Agreement, pay to the Company from Replacement Funds an amount which shall not exceed the Fair Value of the Equipment transferred. The Fair Value of such Equipment and the basis for the Company's title to the Equipment shall be set forth in documents substantially in the forms provided in Section 3.4 of the Agreement.

(3) It is understood and agreed that the Equipment shall constitute and be a part of the Trust Equipment under the Agreement, subject to all terms and conditions thereof in all respects as though the Equipment had originally been a part of the Trust Equipment specifically described therein.

(4) Except as amended and supplemented hereby the Agreement shall remain in full force and effect.

(5) This Fifth Supplemental Agreement has been simultaneously executed in several counterparts, each of which shall be deemed to be an original and all such counterparts shall together constitute but one and the same instrument.

IN WITNESS WHEREOF, the Company and the Trustee have caused their names to be signed hereto by their officers thereunto duly authorized and their corporate seals, duly attested, to be hereunto affixed as of the day and year first above written.




