This letter is written in reference to two Security Agreements and Chattel Mortgages ("Chattel Mortgages") and two Security Agreements - Assignments of Accounts ("Assignments of Accounts") executed by and between Glenco Transportation Services, Inc., a Texas corporation, as Debtor, and Capital National Bank, as Secured Party (collectively referred to as "Security Agreements"). The first Chattel Mortgage and Assignment of Accounts were executed on June 1, 1976 and created security interests in four (4) railroad tank cars, Serial Numbers. GLN-X 24000, 24001, 24002, 24003, and all of the Debtor's accounts and contract rights arising under a Management Agreement with Richmond Leasing Company and all leases now or hereafter existing with respect to said tank cars. These instruments were recorded in your offices on January 5, 1977, at 2:40 p.m., the Chattel Mortgage under Recordation Number 8647, and the Assignment of Accounts under Recordation Number 8647-A. The second Chattel Mortgage and Assignment of Accounts were executed on October 4, 1977 and created security interests in six (6) railroad tank cars, Serial Numbers. GLN-X 33300, 33301, 33302, 33303, 33304, and 33305, and all of the Debtor's accounts and contract rights arising under a Management Agreement with Richmond Leasing Company and all leases now or hereafter existing with respect to said tank cars. These instruments were recorded in your offices on October 13, 1977, at 9:20 a.m., the Chattel Mortgage under Recordation Number 9036, and the Assignment of Accounts under recordation number 9036-A.






