





("Chemlease"), at its office at 130 Tri-County Parkway, Cincinnati, Ohio, in lawful money of the United States of America, the principal amount of One hundred nine thousand twenty-nine Dollars (\$109,029), and to pay interest on the principal amount hereof at a rate per annum equal to 12%, such payments of principal and interest to be in (a) one installment equal to \$4,296, payable on the date hereof, (b) fifty-six consecutive monthly installments each equal to \$1,432, payable on the fifteenth day of each month, commencing April 15, 1979, and ending on November 15, 1983, and (c) a final installment equal to \$82,554, payable on December 15, 1983.

This Note is the Note referred to in a certain Security Agreement, dated the date hereof, between the Payor and Chemlease and is subject to prepayment and the maturity hereof may be accelerated, all as provided in said Security Agreement.

Should any payment hereunder become due and payable on other than a business day, the maturity thereof shall be extended to the next succeeding business day. For purposes hereof, "business day" shall mean any day which is not a Saturday, Sunday or legal holiday in the State of Ohio.


