EQUIPMENT LEASES ASSIGNMENT

THIS EQUIPMENT LEASES ASSIGNMENT, made as of the 1st day of October, 1984, by and between LESLIE COAL MINING COMPANY, a Delaware corporation ("Assignor"), and SIDNEY COAL COMPANY, INC., a Kentucky corporation ("Assignee").

W I T N E S S E T H:

Recitals. Assignor is a party to the Equipment Leases (copies of which have been delivered to Assignee) as defined in Paragraph 3 of the Recitals to the Purchase Agreement between Assignor, McInnes Coal Mining Company, a Delaware corporation, Carolina Power & Light Company, a North Carolina corporation, and Assignee dated as of October 1, 1984 (the "Purchase Agreement"), and listed in Section 6.2 of the Disclosure Schedule referred to therein. Pursuant to Article I(e) of the Purchase Agreement, Assignor wishes to assign the Equipment Leases, and Assignor's entire interests in the Leased Assets (including without limitation the Preparation Plant), leased pursuant to the Equipment Leases, to Assignee and Assignee wishes to accept such assignment, on the terms and conditions set forth herein. Terms defined in the Purchase Agreement shall have the same meanings herein, except as otherwise expressly provided herein or as the context hereof otherwise requires.

NOW, THEREFORE, in consideration of the Purchase Price and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

Section 1. Assignor hereby sells, assigns, transfers and sets over unto Assignee, upon the terms and conditions herein set forth, the Equipment Leases, and Assignor's entire interests in the Leased Assets (including without limitation the Preparation Plant) leased pursuant to the Equipment Leases.

Section 2. Assignee hereby accepts the foregoing assignment and transfer of the Equipment Leases upon the terms and conditions herein contained.

Section 3. Assignee hereby expressly and unconditionally assumes and agrees to observe, keep, carry out and perform the obligations of Assignor under the Equipment Leases and under each of the Operative Documents (as such term is defined in Section 25 of the Equipment Leases) to which Assignor is a party or by which the Assignor is bound arising from actions occurring after the date hereof, on the terms and conditions set forth in the Purchase Agreement.

Section 4. This Assignment and Assumption shall be binding on and inure to the benefit of the parties hereto and their respective successors and assigns.

Section 5. This Assignment and Assumption shall be executed, performed and interpreted in accordance with the substantive laws of Kentucky.

Section 6. Any notice or other communication under or in connection with this Assignment and Assumption shall be in writing and, if to Assignor, shall be addressed to




