

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, SOUTHWESTERN STATES MANAGEMENT CO., as Lessor and MISSOURI-KANSAS-TEXAS RAILROAD COMPANY, as Lessee, entered into a Lease dated May 27, 1977, filed and recorded under Section 20C of the Interstate Commerce Act as Docket No. 8848 (the "Lease") originally providing for the lease of 401 70-ton open-top and covered hopper cars as described in said Lease and as described as Exhibit A attached and incorporated by reference herein; and

WHEREAS, it is the desire of the parties thereto to terminate said Lease effective as of midnight, June 30, 1980.




