

RECITALS:

Lessee is leasing from Lessor pursuant to the above-referenced Lease 68 89' 4" flush deck flat cars (the "Cars").

The Lease was recorded with the Interstate Commerce Commission on July 20, 1970 pursuant to Section 20c of the Interstate Commerce Act (now 49 USC §11303) and assigned recordation number 5785-A.

The Lease was deposited with the Registrar General of Canada pursuant to Section 86 of the Railway Act of Canada.

Section 4 of the Lease provides that the Cars may be renumbered provided that the Lessor shall have been given notice of the renumbering and the notice shall have been deposited or recorded in such locations as the Lease had been deposited or recorded.
