PARTIAL RELEASE

This PARTIAL RELEASE dated as of September 1, 1989 ("Partial Release"), by and between Trailer Train Company, a Delaware corporation ("TTC") and C.I.T. Leasing Corporation, a Delaware corporation, as Agent for The CIT Group/Equipment Financing, Inc., formerly C.I.T. Corporation, ("CIT").

W I T N E S S E T H:

WHEREAS, CIT, Lessor, and TTC, Lessee, entered into that certain Lease of Railroad Equipment dated as of September 1, 1970, which Lease of Railroad Equipment was recorded with the Interstate Commerce Commission ("ICC") on September 3, 1970 under Recordation No. 5817-A;

WHEREAS said Lease of Railroad Equipment was extended for a five year term commencing September 1, 1985 ("the Lease") which extension was recorded with the Interstate Commerce Commission on April 18, 1986 under Recordation No. 5817-D; and

WHEREAS, the parties herein wish to terminate and delete certain units of equipment from the Lease.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the parties herein release, discharge, delete and terminate from the Lease the three hundred and eighty-one hopper cars identified in Schedule A attached hereto.
