

RECITALS:

INTERSTATE COMMERCE COMMISSION

1. Manufacturers National Bank of Detroit, as Vendor, and the Detroit, Toledo and Ironton Railroad Company ("DT&I"), as Vendee, entered into a conditional sale agreement ("CSA") dated as of July 20, 1971, for the conditional sale of eight locomotives, which CSA was recorded with the Interstate Commerce Commission on July 20, 1971, and assigned recordation No. 6249.

2. Said locomotives are six GP 38 AC and two SD 38 diesel electric locomotives, numbered respectively 215 through 220, both inclusive, and 253 and 254.

3. Pursuant to said CSA, Section 4.5, DT&I may renumber said locomotives by giving notice to the vendor of renumbering and recording the new numbers in those offices where the original agreement was recorded.

NOW, THEREFORE, DT&I serves notice that said locomotives will be renumbered as shown on Schedule A, attached hereto and made a part hereof but the locomotives shall otherwise remain subject to all the terms and conditions of the above referenced agreement.
