(Stauffer Chemical - Lease No. 2) INTERSTATE COMMERCE COMMISSION

WHEREAS, under the Lease of Railroad Equipment, dated as of September 10, 1971 between United States Leasing International, Inc. (the "Lessor") and Stauffer Chemical Company (the "Lessee"), Lessee acquired the possession and use of the railroad equipment described in Schedules A-1 through A-5 attached to the Lease; and


WHEREAS, on or about July 22, 1986 all principal and interest on said Note has been paid to the Secured Party; and
