
A general description of the equipment covered by the enclosed Satisfaction and Bill of Sale is shown on Exhibit C of said document.

SATISFACTION AND BILL OF SALE

WHEREAS, ACF Industries, Incorporated (hereinafter referred to as the "Builder") and St. Louis-San Francisco Railway Company, now by merger Burlington Northern Railroad Company (hereinafter referred to as the "Railroad"), have entered into a Conditional Sale Agreement (No. 78) dated as of October 1, 1971, as amended, (hereinafter referred to as the "Agreement"), covering the railroad equipment described in Exhibit A hereto (hereinafter referred to as the "Equipment");

WHEREAS, the Conditional Sale Agreement was recorded with the Interstate Commerce Commission in accordance with Section 11303 of the Interstate Commerce Act on October 12, 1971, and assigned Recordation No. 6346;

WHEREAS, the Builder thereafter assigned its rights under the Conditional Sale Agreement and its right, title, and interest to the Equipment to The Boatmen's National Bank of St. Louis (hereinafter referred to as the "Agent"), pursuant to an Agreement and Assignment dated as of October 1, 1971, between the Builder and Agent and said Agreement and Assignment was filed with the Interstate Commerce Commission on November 1, 1971, and assigned Recordation No. 6346-A. A subsequent amendment to the Conditional Sale Agreement was filed with the Interstate Commerce Commission on July 2, 1980, and assigned Recordation No. 6346-B;

WHEREAS, Pacific Car and Foundry Company (hereinafter referred to as the "Builder"), and St. Louis-San Francisco Railway Company, now by merger Burlington Northern Railroad Company

(hereinafter referred to as the "Railroad"), have entered into a Conditional Sale Agreement (No. 79) dated as of October 1, 1971, (hereinafter referred to as the "Agreement"), covering the railroad equipment described in Exhibit B hereto (hereinafter referred to as the "Equipment"), and all right, title and interest of the Builder in and to the Agreement was assigned to The Boatmen's National Bank of St. Louis (hereinafter referred to as the "Agent") pursuant to an Agreement and Assignment dated as of October 1, 1971, between the Builder and the Agent; and said Agreement and Assignment was filed on November 2, 1971, as one document with the Interstate Commerce Commission pursuant to Section 11303 of the Interstate Commerce Act and assigned Recordation No. 6386; and

WHEREAS, Ortner Freight Car Company (hereinafter referred to as the "Builder"), and St. Louis-San Francisco Railway Company, now by merger Burlington Northern Railroad Company (hereinafter referred to as the "Railroad"), have entered into a Conditional Sale Agreement (No. 80) dated as of October 1, 1971, (hereinafter referred to as the "Agreement"), covering the railroad equipment described in Exhibit C hereto (hereinafter referred to as the "Equipment"), and all right, title and interest of the Builder in and to the Agreement was assigned to The Boatmen's National Bank of St. Louis (hereinafter referred to as the "Agent") pursuant to an Agreement and Assignment dated as of October 1, 1971, between the Builder and the Agent; and said Agreement and Assignment was filed on November 2, 1971, as one document with the Interstate

Commerce Commission pursuant to Section 11303 of the Interstate Commerce Act and assigned Recordation No. 6385; and


WHEREAS, the Agent has been paid the full indebtedness in respect of the purchase price of the Equipment, together with interest and all other payments as provided in the Agreements and the Railroad has performed all obligations therein contained.

NOW, THEREFORE, the Agent, in accordance with the provisions of the Agreements does hereby acknowledge that the Agreements have been satisfied in full and does hereby sell, assign and transfer to the railroad all its title and property interest in the Equipment described in Exhibits A, B, and C, free of all liens and encumbrances created or retained by the Agreements.

This Satisfaction and Bill of Sale is simultaneously executed in several counterparts, each of which so executed is deemed to be an original, and such counterparts together constitute but one and the same instrument.

IN WITNESS WHEREOF, The Boatmen's National Bank of St. Louis, as agent as aforesaid, has caused its corporate name to be hereunto subscribed and its corporate seal to be duly affixed and attested by its officers thereunto duly authorized this 17th day of November, 1988.
