

RELEASE OF COLLATERAL

INTERSTATE COMMERCE COMMISSION

UPTOWN NATIONAL BANK OF CHICAGO (UPTOWN), in consideration of the partial prepayment of principal owed to it by TEMCO LEASING COMPANY (TEMCO) under the Loan and Security Agreement between UPTOWN and TEMCO dated June 9, 1986 and secured by TWENTY (20) tank cars listed in said Agreement, hereby releases and quit-claims to TEMCO, its successors and assigns, all right, title and interest whatsoever which UPTOWN may have in the sixteen (16) tank cars listed in Exhibit A hereto, together with any and all rights which UPTOWN may have in any leases pertaining thereto or proceeds therefrom, as listed on Schedule B hereto.
