



Memorandum of a Lease Agreement, No. 113084, made and entered into as of November 30, 1984 by and between TC-79 PARTNERSHIP, an Illinois partnership ("Lessor") and SOO LINE RAILROAD COMPANY, a Minnesota corporation, ("Lessee").

W I T N E S S E T H:

1. Lessor has agreed to furnish to the Lessee, and the Lessee has agreed to lease from Lessor the railroad cars shown on Rider "A" attached hereto, and such additional Riders as may be added hereto from time to time by agreement of the parties and signed by their duly authorized representatives.


