AMENDMENT

The Agreement, Management Contract, between Northbrook Corporation (f/k/a Funding Systems Railcars, Inc.) and Greenbrier Leasing Corp., dated April 9, 1985 is amended as follows effective January 1, 1987.

- 1) Section 2(a) is deleted in its entirety and the following added "The term of this Agreement ("Term") shall commence effective January 1, 1987 and continue for twelve (12) months unless terminated sooner in accordance with the provisions of this Agreement."
2. In Section 3 the following is deleted "Owner preapproves the placement of these cars in service with the Southern Pacific Transportation Company until December 31, 1986".
3. All other terms and conditions remain unchanged and in effect.


