AMENDMENT TO SECURITY AGREEMENT

INTERSTATE COMMERCE COMMISSION

THIS AMENDMENT to Security Agreement as of August 28, 1986 by and between Greenbrier Leasing Corporation, a Delaware corporation ("Greenbrier") and First National Bank of Minneapolis ("Lender"), a national banking association.

W I T N E S S E T H:

WHEREAS, Greenbrier and Lender have entered into a Security Agreement dated as of April 1, 1986, which was filed with the Interstate Commerce Commission on April 2, 1986, and assigned recordation number 14933; and

WHEREAS, Greenbrier and Lender wish to amend the Security Agreement to correct a mistake in the description of the equipment;

NOW THEREFORE, in consideration of the foregoing and of the mutual covenants contained herein, Greenbrier and Lender agree as follows:

Section 1. The "Description of Vehicles" in Schedule 1 of the Security Agreement is hereby deleted and shall be replaced by the following Description of Vehicles:

"Twenty-one (21) five-unit well-type intermodal container cars manufactured by Gunderson, Inc. of Portland, Oregon, bearing reporting mark and the numbers NYSW 6700 through 6719, inclusive and GBRX 2011."

Section 2. Except as expressly modified, amended or supplemented, this Amendment to Security Agreement shall not be deemed or construed to have altered, amended or modified the Agreement heretofore entered into by the parties.


