Dear Miss Boston:

I am in receipt of your letter dated December 17, 1981. In that letter you requested information regarding the effective date of transfer of the above referenced asset to Dr. and Mrs. Yenikomshian's Revocable Living Trust.

Because the Trust to which this asset is to be transferred is a Revocable Trust, all incidents of taxation will be reflected on Dr. and Mrs. Yenikomshian's personal income tax return. Therefore, the effective date of the transfer is not significant from an income tax standpoint. However, if it would be easier for your purposes in completing Form 1099, I would suggest that we treat the effective date as of January 1, 1982. That date will avoid the necessity for you to complete two Form 1099s for the 1981 calendar year.


