Dear Madam Secretary:

On July 31, 1982, Wells Fargo Equipment Leasing Corporation, a California corporation ("WFELC"), was merged into its parent, Wells Fargo Leasing Corporation, also a California corporation ("WFLC"). A certified copy of the Certificate of Ownership effecting this merger is attached as Exhibit A. Upon the effectiveness of this merger and by operation of law, the separate existence of WFELC ceased and WFLC succeeded to all the rights and property of WFELC and became subject to all the debts and liabilities of WFELC.

Exhibit B hereto sets forth the instruments filed and recorded with the Commission to which WFELC is a party. We would appreciate your cross-referencing all of the filings set forth therein to indicate that WFLC is successor by merger to WFELC. Seven copies of this letter and its exhibits are enclosed for filing with the Commission, so that one copy may be placed in each of the five Commission files noted on Exhibit B and two copies may be returned to Mr. Charles T. Kappler of Alvord and Alvord, who will be filing this letter on our behalf.

Also enclosed is our check for \$50.00 in payment of the Commission's fee of \$10.00 for each cross-referencing.







1. They are the President and the Assistant Secretary, respectively, of WELLS FARGO LEASING CORPORATION, a California corporation.



3. The Board of Directors of WELLS FARGO LEASING CORPORATION has adopted the following resolutions by unanimous written consent:



4. The effective date of the merger described above shall be July 31, 1982.




