

TERMINATION OF LEASE AGREEMENT INTERSTATE COMMERCE COMMISSION

THIS TERMINATION OF LEASE AGREEMENT, dated as of July 31, 1989 by Atlantic & Western Financial Corporation, a Delaware corporation ("A&W") and Atlantic & Western Railway Company, a North Carolina corporation (successor to Atlantic & Western Corporation) ("Railway").

1. Recitals. A&W and Railway entered into a Lease Agreement dated as of December 26, 1977 (the "Lease") with respect to certain railroad boxcars described in the Lease (the "Boxcars"). The Lease is on file at the Interstate Commerce Commission ("ICC") under Recordation No. 9415 filed on June 1, 1978.

The Boxcars have been sold and the parties hereto wish to accommodate the new owner and relinquish all claims to the Boxcars under the Lease. The purpose of this Termination of Lease Agreement is to terminate the Lease and provide a formal termination document for filing with the ICC.

2. Termination. The Lease is hereby terminated.
