

Gentlemen:

We have entered into a Hulk Purchase Agreement dated April 1, 1978 (hereinafter called the Hulk Purchase Agreement), which was filed and recorded with the Interstate Commerce Commission on June 2, 1978, at 2:55 p.m., and assigned Recordation No. 9419. Attached to the Hulk Purchase Agreement as Exhibit A is a description and list of groups of road numbers from which the Hulks were to be selected and the purchase price of the Hulks. Inasmuch as the parties hereto desire to amend the Hulk Purchase Agreement to describe only those Hulks which were sold pursuant to the Hulk Purchase Agreement on or before December 28, 1978, the last date on which reconstruction could be completed for equipment sold pursuant to the terms of that agreement, the Hulk Purchase Agreement is hereby amended by deleting Exhibit A thereto and substituting Exhibit A hereto in lieu thereof.

Except as amended hereby, the Hulk Purchase Agreement remains unaltered and in full force and effect.

This Amendment may be executed in any number of counterparts, which together shall constitute but one instrument.
