ASSIGNMENT AND ASSUMPTION AGREEMENT

This Assignment and Assumption Agreement, executed this 31st day of 3rd, 1989 and effective February 29, 1988, is by and between First Security Bank of Utah, N.A. (hereinafter "Assignor") and First Security Leasing Company of Nevada (hereinafter "Assignee").

W I T N E S S E T H:

Assignor hereby grants, transfers, assigns and delegates to Assignee, effective February 29, 1988, all of its right, title, interest and obligations in and to or with respect to that certain Trust Agreement dated as of June 15, 1980 (the "Trust Agreement") between Assignor as Owner and First Security Bank of Idaho, N.A. as Trustee ("Trustee"), that certain Trust Estate (as defined in the Trust Agreement), and that certain Participation Agreement dated as of June 15, 1980 ("Participation Agreement") among The Dow Chemical Company as Lessee, Mercantile-Safe Deposit and Trust Company as Agent, and the Teacher Retirement System of Texas as Investor, and any other documents relating to such Trust Agreement, Trust Estate or Participation Agreement to which Assignor is a party and which are now in effect, together with any rents or payments received thereunder or any increases in said rents or payments, to wit: Lease of one hundred seventeen (117) tank cars, five (5) diesel electric locomotives, thirty-seven (37) covered hopper cars and twenty-eight (28) pressure differential cement cars pursuant to that certain Lease of Railroad Equipment dated as of June 15, 1980, and that Amendment to Lease of Equipment dated as of December 15, 1980, between Trustee as Lessor and Dow Chemical, Inc. as Lessee.

Assignee hereby confirms that it shall be deemed a party to the Trust Agreement and the Participation Agreement and shall be bound by all of the terms of and undertake all of the obligations of Assignor under the Trust Agreement and the Participation Agreement and any other documents relating thereto to which Assignor is a party and which are now in effect.

This Assignment and Assumption Agreement shall inure to the benefit of the successors and assigns of Assignee and shall bind Assignee's legal representatives, successors and assigns.
