

AMENDMENT TO
LOAN AND SECURITY AGREEMENT AND ASSIGNMENT

AMENDMENT TO LOAN and SECURITY AGREEMENT AND ASSIGNMENT dated as of November 1, 1984 is by and between Evans Railcar Leasing Company, an Illinois corporation ("Debtor"), and Manufacturers Hanover Leasing Corporation, a New York corporation ("Secured Party").

WITNESSETH, that

WHEREAS, Debtor has heretofore executed and delivered to Secured Party that certain Loan and Security Agreement dated as of March 26, 1981 and recorded with the Interstate Commerce Commission ("ICC") on March 30, 1981 as Recordation No. 13020 (the "Original Agreement"), to secure Debtor's 12-3/4% Promissory Note, dated March 26, 1981, payable to the order of Secured Party in the original principal amount of \$5,500,000.00 (the "Note"); and

WHEREAS, Debtor and Secured Party entered into that certain Supplement dated as of March 26, 1981 and recorded with the ICC on March 30, 1981 as Recordation No. 13020-A (the "First Supplement"); and

WHEREAS, the Parties entered into that certain Supplemental Agreement dated as of June 16, 1982 and recorded with the ICC on April 4, 1983 as Recordation No.

13020-B (together with the Original Agreement and the Supplement collectively the "Agreement"); and

WHEREAS, as additional security for Debtors obligations under the Note, Debtor and Secured Party entered into that certain Assignment of Lease dated June 16, 1982 and recorded with the ICC on April 4, 1983 as Recordation No. 13020-C (the "Rohm and Haas Assignment").

WHEREAS, the Parties desire to amend and correct the Agreement and the Rohm and Haas Assignment as hereinafter provided.

NOW, THEREFORE, in consideration of the premises herein contained and of \$10.00 and other good and valuable consideration paid by Debtor to Secured Party, the receipt and sufficiency of which are hereby acknowledged, the Parties agrees as follows:

AGREEMENT

1. The Agreement is hereby amended by deleting the period at the end of the definition of "Lease" in Section 1.1 thereof and adding the phrase "as the same relates and pertains to Schedules 1 and 2 thereto, each dated as of October 23, 1978."

2. The Rohm and Haas Assignment is hereby amended by deleting from the second paragraph of the Recitals there- to the phrase "(the "Lease")" and substituting therefor the following:

as the same relates and pertains to Schedule 8 thereto dated December 15, 1980, as said Schedule 8 relates and pertains to the railcars bearing car report- ing marks USLX 21696-21698, inclusive (said lease as the same relates and pertains to said Schedule 8 as said Schedule 8 relates and pertains to the railcars bearing car reporting marks USLX 21696-21698, inclusive, herein called the "Lease").

3. Except as hereby amended, the Agreement and the Rohm and Haas Assignment remain in full force and effect, and the Agreement and the Rohm and Haas Assignment, as hereby amended, are ratified, confirmed and approved.


