

NOTICE OF SUBLEASE TERMINATION AND RENUMBERING
INTERSTATE COMMERCE COMMISSION

DATE: August 27, 1986

1. Grand Trunk Western Railroad Company (Grand Trunk) is leasing certain covered hopper cars pursuant to a lease dated as of August 1, 1972, with the Bank of New York. Said lease was filed with the Interstate Commerce Commission (ICC) on September 13, 1972, and assigned recordation number 6736A-B.

2. Thereafter Grand Trunk subleased 12 covered hopper cars subject to said lease to Amway Corporation (Amway) pursuant to a sublease of railroad equipment dated January 13, 1982.


3. Said 12 covered hopper cars were renumbered with Amway reporting marks and the sublease and statement of new identifying numbers were each filed with the ICC on January 18, 1982, and assigned recordation numbers 6736 D and E, respectively.

4. The sublease has been terminated in accordance with its terms and the subleased cars were restenciled with their original reporting marks.


