MEMORANDUM OF LEASE FFB 10 1981 -11 30 AM

INTERSTATE COMMERCE COMMISSION

This is the memorandum of the lease pursuant to Letter Agreement dated July 21, 1980 as supplemented by Letter Agreement dated July 22, 1980 ("Letter Agreements"), between Marble Associates, a Limited Partnership, lessor, and Chicago and North Western Transportation Company, lessee, concerning equipment described as follows:
