Memorandum of a Lease Agreement, No. 031886, made and entered into as of April, 1986 by and between TRANSPORTATION CORPORATION OF AMERICA, an Illinois corporation, ("Lessor") and CSX TRANSPORTATION, INC.,* a Virginia corporation, ("Lessee").
