INTERSTATE COMMERCE COMMISSION

AGREEMENT dated as of July 1, 1980 amending SUPPLEMENTAL AGREEMENT FOR RENT ADJUSTMENT dated as of June 1, 1978 between The Commonwealth Plan, Inc. as Lessor and Pennsylvania Power & Light Company as Lessee, supplementing Equipment Leasing Agreement No. 5 dated the same date and between the same parties.


