RELEASE OF "EQUIPMENT MORTGAGE AND ASSIGNMENT OF LEASE RENTALS"

In consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration paid by DATX Associates (the "Company") to The First National Bank of Chicago ("FNBC"), the receipt of which is hereby acknowledged by FNBC, FNBC hereby assigns, transfers, and sets over unto DATX Associates, its successors and assigns, all the right, title and interest of FNBC in and to (1) all railroad cars owned by the Company including but not limited to those described on Exhibit A attached hereto and (2) all leases of equipment, including but not limited to that Railroad Cars Lease Agreement lease between the Company and Wisconsin Industrial Fuel Oil Inc. dated December 29, 1980. 
