Amendment to Schedule 7 to Lease dated January 1, 1982, (the "Lease") by and between Evans Railcar Leasing Company ("Lessor") and Louisville, New Albany, and Corydon Railroad Company ("Lessee");

W I T N E S S E T H :

WHEREAS, Lessor and Lessee have previously entered into that certain Lease dated November 30, 1977; and

WHEREAS, Schedule 7 dated February 17, 1981 to the Lease was recorded with the Interstate Commerce Commission at 8:55 a.m. on July 21, 1981 as Recordation No. 13194-B; and

WHEREAS, the copy of Schedule 7 recorded with the Interstate Commerce Commission (the "ICC") reflected an incorrect Lease date of December 8, 1980; and
