

WHEREAS, The Darby Products of Steel Plate Corporation, Pullman Incorporated (Pullman-Standard Division), General American Transportation Company, ACF Industries, Incorporated, Ortner Freight Car Company, and Evans Products Company, (hereinafter called the "Vendors") and the St. Louis-San Francisco Railway Company, now by merger Burlington Northern Inc. (hereinafter called the "Railway") have entered into Conditional Sale Agreements dated as of January 15, 1966 (hereinafter called the "Agreements"), covering the railroad equipment described in Schedule A hereto (hereinafter called the "Equipment"), and all right, title and interest of the Vendors in and to the Agreements, was assigned to the Boatmen's National Bank of St. Louis (hereinafter called the "Assignee") pursuant to Agreements and Assignments dated as of January 15, 1966 between the Vendors and the Assignee; and the Agreements and said Agreements and Assignments were filed on January 26, 1966, February 3, 1966, February 14, 1966, February 18, 1966, March 2, 1966, March 4, 1966, respectively, with the Interstate Commerce Commission pursuant to Section 11303 of the Interstate Commerce Act (Recordation Nos. 3645, 3661, 3670, 3680, 3692, and 3698):
