INTERSTATE COMMERCE COMMISSION

In consideration of their mutual promises and other good and valuable consideration, Transportation Corporation of America, an Illinois corporation, (hereinafter called "TCA") and Nevada Northern Railway Company, a Maine corporation, (hereinafter called "Nevada Northern") hereby mutually agree to terminate the Lease Agreement dated as of May 6, 1981 between TCA, as lessor, and Nevada Northern, as lessee, pertaining to the following described railroad equipment:
