Gentlemen:

This refers to the Equipment Trust Agreement dated as of June 1, 1979, between this Company and The First National Bank of Chicago, One First National Plaza, Chicago, Illinois 60670, as Successor Trustee to Wells Fargo Bank, N.A., (the "Agreement"), which was recorded with your office on June 12, 1979, and assigned recordation number 10497.

Section 5.07 of the Agreement provides that, in the event the Company intends to change the car numbers of any units of railroad equipment covered by the Agreement, it shall file and record with your office a statement of the new car numbers to be substituted therefor. The Company desires to substitute new car numbers for certain of the car numbers listed on Schedule A to the Second Supplemental Equipment Trust Agreement dated as of October 1, 1982, amending the Agreement. The car numbers to be changed and the car numbers to be substituted therefor are set forth in Schedule A hereto.


