PARTIAL RELEASE OF MORTGAGE INTERSTATE COMMERCE COMMISSION

THIS AGREEMENT, made and entered into this 8 day of January, 1981, by and between R. W. McMAHON, hereinafter referred to as "Mortgagor", and BANK OF OKLAHOMA, N.A., located at One Williams Center, Tulsa, Oklahoma, hereinafter referred to as "Bank".

W I T N E S S E T H:

WHEREAS, under the date of June 6, 1979, Mortgagor made, executed and delivered to Bank that certain Mortgage On Tank Cars ("Mortgage") filed of record with the Interstate Commerce Commission on June 18, 1979, Recordation No. 10514, covering various tank cars, one of which is described as follows:

One (1) 33,500 gallon, Class ICC 112A 340-W
Tank Car, initialed and number RUDX204,

together with all fittings and appliances now or hereafter connected therewith, and any replacements of any parts thereof or additions thereto; and

WHEREAS, said Mortgage was given to secure the original principal sum of TWO HUNDRED SEVENTY-SIX THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$276,500.00) as evidenced by those certain promissory notes dated of even date therewith made, executed and delivered by the Mortgagor to the Bank, more specifically described as follows:

A. Promissory Note in the principal amount of One Hundred Fifty Thousand and No/100 Dollars (\$150,000.00), payable in installments of principal and interest as provided in said Note, and bearing interest at the rate of One Percent (1%) over Bank of Oklahoma prime, floating, from maturity until paid; and

B. Promissory Note in the principal amount of One Hundred Twenty-Six Thousand Five Hundred and No/100 Dollars (\$126,500.00), which has been renewed by that certain promissory note in the principal amount of One Hundred Twenty Thousand Three Hundred Thirty-One and 31/100 Dollars (\$120,331.31), with principal and interest payable as provided in said Note, and bearing interest at the rate of One Percent (1%) over Bank of Oklahoma prime, floating, from maturity until paid.

WHEREAS, said Mortgagor desires to remove from the lien created by the Mortgage on the above described tank car;

NOW, THEREFORE, in consideration of the premises, it is mutually agreed by the parties hereto that there shall be released from the Mortgage and the lien created thereby the following tank car:

One (1) 33,500 gallon, Class ICC 112A 340-W Tank Car, initialed and number RUDX204,

PROVIDED, HOWEVER, this release is given upon the express condition that all liens, interests, rights and powers conveyed, transferred, granted or assigned in said Mortgage to the Bank in and to all other property described therein shall be and remain in full force and effect and shall not otherwise be impaired or affected by any of the provisions hereof.

IN WITNESS WHEREOF, the Bank of Oklahoma, N.A., the holder of the Notes and Mortgage described above, has caused these presents to be executed in its name this 8 day of January, 1981.
