RECITALS:

Great American Management Services, Inc. ("Sublessor") and First Security State Bank as Owner Trustee entered into a lease dated as of May 1, 1978 (the "Lease") of 229 Flat Cars (the "Cars") bearing road numbers (105 Ford Bi-Level Semi) ROCK 990042 to ROCK 990146, (45 Ford Tri-Level Full) ROCK 995000 to ROCK 995044, (42 GM Bi-Level Full) ROCK 990000 to ROCK 990041, and (37 GM Tri-Level Full) ROCK 995045 to ROCK 995081, all inclusive, which Lease was recorded with the Interstate Commerce Commission pursuant to Section 20c of the Interstate Commerce Act (now 49 USC Section 11303) and assigned recordation number 9498-C. Sublessor and William M. Gibbons, Trustee of the Property of Chicago, Rock Island and Pacific Railroad Company (the "Initial Sublessee") entered into a sublease dated as of May 1, 1978 (the "Sublease") of the Cars, which Sublease was recorded with the Interstate Commerce Commission pursuant to said Section 20c of the Interstate Commerce Act and assigned recordation number 9498-E. The Sublease is being terminated by Sublessor and the Initial Sublessee, and Sublessor is entering into a new Sublease (the "New Sublease") with Grand Trunk Western Railroad Company dated as of May 1, 1978 with respect to 150 of the same Cars.

Section 5 of the Prime Lease provides that the cars may be renumbered provided that the Lessor thereunder and Vendor identified therein shall have been given notice of the renumbering and the notice shall have been duly filed, recorded and deposited by the Sublessor in such locations as the Prime Lease had been filed, recorded and deposited.






