

This THIRD SUPPLEMENTAL AGREEMENT, dated as of November 1, 1981, between MORGAN GUARANTY TRUST COMPANY OF NEW YORK, a New York trust company, as Trustee (hereinafter called the Trustee), and UNION PACIFIC RAILROAD COMPANY, a Utah corporation (hereinafter called the Company).

WITNESSETH:

WHEREAS, the Trustee and the Company have heretofore entered into (i) an Equipment Trust Agreement, dated as of June 1, 1979, which was filed and recorded pursuant to 49 U.S.C. §11303 on July 10, 1979 and assigned Recordation No. 10612; (ii) a First Supplemental Agreement, dated as of July 1, 1979, to such Equipment Trust Agreement, which was filed and recorded pursuant to 49 U.S.C. §11303 on August 8, 1979, and assigned Recordation No. 10612-A; and (iii) a Second Supplemental Agreement, dated as of May 1, 1980, to such Equipment Trust Agreement, which was filed and recorded pursuant to 49 U.S.C. §11303 on May 16, 1980 and Assigned Recordation No. 10612-B (such Equipment Trust Agreement, as amended, being hereinafter called the Agreement); and

WHEREAS, pursuant to the Agreement, the Trustee has issued \$20,300,000 aggregate principal amount of Union Pacific Equipment Trust No. 4 of 1979 Equipment Trust Certificates (hereinafter

called the Trust Certificates); and

WHEREAS, Section 8.4 of the Agreement provides that the Company and the Trustee without the consent of the holders of the Trust Certificates then outstanding may from time to time and at any time enter into an agreement or agreements supplemental to the Agreement for the purpose of making any provisions in regard to matters or questions arising under the Agreement as shall not adversely affect the interests of the holders of the Trust Certificates then outstanding or the rights, duties or immunities of the Trustee; and

WHEREAS, the Company and the Trustee desire to execute and deliver this Third Supplemental Agreement for the purpose of amending the Description of Trust Equipment (hereinafter called the Description of Trust Equipment) set forth as Schedule A thereto, and such amendment will not adversely affect the interests of the holders of the Trust Certificates not outstanding or the rights, duties or immunities of the Trustee;

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the parties hereto agree that the Agreement be, and it hereby is, amended as follows:

1. There is hereby deleted from the Description of Trust Equipment the following reference:


